# CAPITAL FUND PROJECTS AND ACTIVITIES

#### **Asphalt Maintenance/Replacement:**

The paving proposals from three contractors are being reviewed by the Engineer, Kipcon. After which time, Management and Council will review the proposals and recommendations. The first phase will include paving the Clubhouse Parking Lot and the walking path.

#### **Maintenance Garage Roof:**

Lemus Construction will be replacing the maintenance garage roof and gutters in September. The contract has been signed by all parties.

# **Improvements at 2101 through 2108 Marshall Court:**

The concrete common walk and entrance walks to the homes to 2101 through 2108 Marshall Court will be replaced. Due to the hill in front of these homes, a retaining wall and railings will be installed as well. Trozzi Construction will be replacing the concrete, Clarke's Landscaping will be installing the retaining wall, and Marano Ironworks will be installing the railings.

# OPERATING FUND PROJECTS AND ACTIVITIES

## **702 Springhouse Court ~ Fire Renovation:**

Eastern Diversified Services (EDS) will be completing the renovation of this home by the end of August.

#### Landscaping:

Clarke's cut 17 times so far this season, with minimal complaints from Residents.

Clarke's Landscaping completed the shrub trimming project with minimal complaints from the Residents.

The Association contracted with Clarke's Landscaping to trim, remove, and plant trees throughout the community. The contract was signed by all parties, and the work will start on August 23<sup>rd</sup>. A notice was sent to those Residents affected by the work.

Davey Tree Service treated specific trees for webworms this period.

The entrance beds were weeded and watered several times this period. Low hanging branches were trimmed throughout, and the curbs were sprayed with weed killer.



#### **Clubhouse Painting:**

Brad is in the process of painting the exterior of the Clubhouse.

#### **Powerwashing:**

Matt completed the power washing on Brunswick Court.

#### **Pool Season:**

The pool season is going smoothly. The lifeguards are doing a fantastic job. We are fortunate to have Matt Frisco maintaining the pool filtration system and chemicals.

While we are pleased to inform the community that our lifeguard contractor, IM Pools, will be returning next year, we are saddened that Hilary will not be returning. IM Pools will be looking for a new pool manager for the 2024 season. Hopefully, most of the guards will return regardless of the manager.

The Pool Party was a complete success. Management received many compliments from attendees, which were forwarded to the Pool Committee. We are very grateful for the incredible efforts and dedication the Committee put into organizing the recent pool event. # Celebrating Original and Long-Term Owners at Morgandale

#### **Phil and Nancy Hommer**

We continue to celebrate Morgandale's 50<sup>th</sup> Anniversary and are honoring long-time residents, Phil and Nancy Hommer. The Hommer's are the original owners of 502 Clarella Court, having moved to Morgandale in December 1973. At the time, Clarella Court was one of the first five courts to be built on the Morgandale property. As a young couple beginning their careers, they were looking for a nice, affordable house that was conveniently located to where they worked and one that had appealing amenities. They looked at the sample home in Brunswick Court and really liked the property, so they decided to purchase their current residence in Clarella Court for \$33,000. That was quite a deal considering the average price of a new car 50 years later is approximately \$48,000, according to Kelley Blue Book (Source: 2023 www.kbb.com.)

Their son and daughter were born a few years after they moved in, and Phil and Nancy were able to find playmates for their son and daughter as well as become friends with other young couples. They recall their children spending much of their free time at the playground and the pool with the friends they made in their neighborhood. One of their children's fondest memories was making tunnels and slides in the giant snow mountains made by the plows in the center of the court parking lots after the big snowstorms. As their children got older, their daughter served as a lifeguard for a few summers and their son rode his bike throughout the community delivering *The North Penn Reporter* to the residents.

Over the years, they have also used the bike path and tennis courts and continue to do so today. Now that their children are grown and have families of their own, their grandchildren enjoy the playground and pool when they visit much like their parents did when they were children. They even have participated in several Morgandale Days. While they never planned on being in Morgandale 50 years later, they are happy they did and attribute their decision to stay to having so many nice neighbors. In fact, they still keep in touch with some of their former neighbors who have moved away. They also like the easy lifestyle and the fact that the property is so well maintained.

When reminiscing about how much Morgandale has changed, aside from having many more courts than there were when they first moved in, they also remember that the pool had a diving board and the playground had baby swings. They also remembered the garden that residents could use that was located where Piedmont Court is now. During the early years, Phil served as court captain for Clarella Court and would get together with other court representatives each month for a meeting. Some of their other memories from the early years include the weekly play groups for young kids and moms in the clubhouse, Easter egg hunts, and ping pong and pool tournaments for adults.

With such fond memories and nice neighbors, there was no reason for them to move. Phil and Nancy feel it has truly been "a fun ride" for them over the past 50 years. We are grateful that they shared their story and memories with us.




#### **HOUSE RULES**

#### **Bathroom Fans**

As part of our ongoing commitment to maintaining a safe and enjoyable living environment within our community, we want to remind you about an essential maintenance task regarding the bathroom fans in your homes. Regular maintenance of these fans is not only necessary for the safety and well-being of all Residents, but also an annual requirement of the Association.

Recent inspections of the bathroom fans have been an eye opener. Contractors are finding many hazardous bathroom fans. The picture below is a fan in horrible condition, that could have caused a fire.



#### 1. Inspection and Repair:

Once a year, please perform a thorough inspection of your bathroom fan to identify any signs of wear and tear, dust and dirt buildup, noise, or malfunction. If you notice any issues, we strongly advise you to stop using your fan until it is cleaned, repaired, or replaced.

#### 2. Cleaning:

Periodic cleaning of your bathroom fan is vital to prevent dust and debris buildup. Blocked or clogged fans can lead to reduced ventilation efficiency and potential overheating, resulting in a fire.

#### 3. Replacement:

If your bathroom fan is outdated, damaged beyond repair, or doesn't meet the current safety standards, it might be necessary to replace it. Newer fans are more energy-efficient and designed to handle moisture effectively. Some of the older fans are combined with the light switch (one switch). If this is the case in your home, we recommend you separate the switches. When considering replacement, please ensure that the new fan meets the required specifications and is installed according to the manufacturer's guidelines.

#### 4. Rules and Regulations:

Please supply Management with a copy of the inspection and invoice every year, before new Leases, and before a Resale, per the Rules and Regulations.

#### MICROPLASTICS FOUND IN HUMAN BLOOD FOR THE FIRST TIME.

This is not meant to scare anyone but to encourage all to reduce our use of plastics as much as possible. Microplastic pollution has been detected in human blood for the first time, with scientists finding the tiny particles in almost 80% of the people tested.

The discovery shows that the particles can travel around the body and may lodge in organs. The impact on health is yet unknown; however, researchers are concerned that microplastic cause damage to human cells in the laboratory. Air pollution particles are already known to enter the body and cause millions of early deaths a year.

High amounts of plastic waste dumped into the environment contaminate the entire planet from the summit of Mt. Everest to the deepest oceans.

Plastic production is set to double by 2040. We have a right to know what all this plastic is doing to our bodies.

Think of this, in the US alone there are roughly 5,000 flights per day. Let's say an average of 200 passengers per plane, two plastic cups used for drinks per passenger per flight. That is about 200,000 plastic cups per day!

Let's be smart about our use of plastics. If we all make small contributions to reducing our plastic use, it will add up to something big!!

The 'Going Green' concept is alive and well with the Residents of Morgandale. Thanks so much for your participation and cooperation. The Recycling/Environmental Committee has scheduled its Fall Recycling Day event for Saturday, September 23<sup>rd</sup>, between 9:00 a.m. and 12:00 noon, rain or shine.

## The following are items that can be recycled:

<u>Cardboard & Paper Recyclable Items</u>: Catalogs, magazines, newspapers, weekly advertisement circulars, junk mail, TV Guides, folders, construction paper, poster paper, shredded paper, spiral notebooks, theme books, and office and school paper. Shredded paper should be put in a bag. Hard cover books can be recycled, however, please take off the front and back hardcover. The metal on spiral books may remain intact.

<u>Co-mingle Recycling Box</u>: Aluminum, tin and bi-metal cans, glass bottles, jars, plastic bottles and jugs (#1 thru #7), telephone books, corrugated cardboard (flattened), cartons (cereal, pasta, tissue, milk), and soft back books.

# **School Bus Safety**

At the beginning of school year, we would like to take a moment to remind everyone in our community about the crucial importance of obeying school bus signals. Ensuring the safety of our children while they travel to and from school is a shared responsibility and adhering to school bus signals is a critical aspect of that responsibility.

We have gotten reports that Residents are turning out of their courts going in the opposite direction of a school bus that is signaling red flashing red lights. When a school bus comes to a stop and activates its flashing red lights and extends the stop arm, it signifies that children are either boarding or disembarking from the bus. Regardless of the direction of travel, all vehicles must come to a complete stop until the bus resumes motion and turns off its flashing red lights.

Our children's safety should always be our top priority, and obeying school bus signals is a vital part of maintaining a secure environment for them. Thank you for your attention to this matter. Let us work together to make this school year safe and enjoyable for all.

#### Financial Sense - Credit Cards

Two months ago, I applied for a store credit card. I decline incentive offers as a matter of standard practice, but I was buying furniture, so the incentive offered me a reasonable savings that I knew I could pay off. The furniture arrived, the bill arrived, with a 32% interest rate on unpaid balances. This prompted me to do a bit of research to see what's happened to credit cards in the last few years.

In 2020, the average credit card interest rate was 16.34%. In 2023, that number is as high as 27.79%, with an average around 22%, according to the Federal Reserve.

Why it matters: A \$5,000 balance at 16% interest rate, over five years to pay it off, equals \$2,295 in additional interest. At 22% interest rate, the interest paid is \$3,285. So, the thing you bought for \$5,000 just cost you \$8,285. By the time you've paid for it, you may have forgotten what you purchased.

I never want you to carry a credit card balance, but I also know that sometimes we do. Yes, life gets in the way, no shame, no judgement, no beating yourself up. This is the time to take charge and get out of debt. Don't waste your hard-earned money paying high interest to a corporation! Take steps to put that interest payment back into your pocket where it belongs.

Here are a couple options to consider:

See if you qualify for a zero percent card transfer. If you do, make sure you can make the required payments to pay it off in the introductory period (or all interests comes back). There is a transfer fee usually associated with these cards but if you are paying 3-5% transfer rate and pay it off during the zero percent period, you are well ahead of the average 22%.

Take a side hustle, I hear the groans, but a short-term job beats years of living in 22% or higher debt! Take a position at a store or gym, dog sit, or help with parttime childcare. Find something that fits your interest, skills, and hours, but remember this is temporary so you're not looking for a CEO position.

Sell stuff, the treadmill that holds your clothes, the bike that is just sitting waiting for a rider, clothing from the wedding three months ago, or the extra car that is a luxury not a need.

If these solutions don't work for you, then you need to go back to bare necessities in the budget. Get rid of cable and/or premium streaming services, eat at home, shop your closet, and find zero cost entertainment options. There are options such as The Philadelphia Museum of Art has 'pay what you wish' the first Sunday of the month. Catch up with a friend as you browse local art galleries. The library provides free access passes to gardens, museums, and shows current movies. There are ways to have enriching experiences without spending money. Tap into your creativity and I bet you can find opportunities that meet your specific interests.

The goal is always to live your best life and that isn't sustainable under a mound of 22% debt.

I want to quickly touch on Student Debt as well. The three-year grace on payments is ending and in October loan payment requirements resume. Now is the time to review outstanding debt, interest rates, and make sure the payments fit into your spending plan. Do this today, not the day before the payment is due. Planning will allow for a peaceful night's rest!






