I acknowledge if issues arise, such as health and safety concerns or other unforeseen circumstances, the Council reserves the right to reevaluate and, if necessary, temporarily close the pool at its discretion during the 2025 season. On my behalf, and on behalf of my children and my guests, I hereby release, covenant not to sue, discharge and hold harmless, the Morgandale Condominium Association, Council for Morgandale, Associa Mid-Atlantic, and their respective officers, directors, employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.
